Response:

Refer to the list of documents below. In September 2010, the NRC Office of Investigations (“OI”) opened an investigation to determine whether Exelon Generation submitted inaccurate or incomplete information to the NRC in decommissioning funding status reports. To the extent the status reports include funding for Exelon Generation’s ownership interest in Salem, the investigation technically included Salem, but Salem was not discussed during the investigation. In January 2013, the NRC issued a letter identifying “apparent” violations of the NRC’s regulations. In April 2013, Exelon Generation objected to the apparent violation recommendation at a pre-decisional enforcement conference. On May 1, 2014, the NRC issued its final decision, concluding that Exelon Generation did provide incomplete information in its decommissioning funding status reports for 2005, 2006, 2007, and 2009, but that the violation was not deliberate and did not present a safety issue. The NRC issued a Notice of Violation with no monetary penalty. OI subsequently opened a follow up investigation regarding representations made during the pre-decisional enforcement conference, but that investigation closed with a finding of no wrongdoing and no enforcement action was taken.
