I, the undersigned, being duly sworn, depose and say, on behalf of Exelon Generation Company, LLC ("Exelon Generation") and not in my individual capacity, that:

- 1. I am the Senior Vice President Portfolio Management & Strategy of Exelon Generation, an applicant under the Zero Emission Certificate Application being submitted jointly by PSEG Nuclear, LLC ("PSEG Nuclear") and Exelon Generation for Salem Unit 1 nuclear power plant located in Lower Alloways Creek Township, Salem County, New Jersey ("Application"):
- 2. Exelon Generation is a co-owner of Salem Unit 1, owning a 42.59 percent ownership interest in the unit, while PSEG Nuclear holds a 57.41 percent ownership interest in the unit and is the NRC-licensed operator of the unit.
- 3. - 5. The statements made in this Affidavit are based upon my examination of the information described in Paragraph 4 above, upon my general knowledge of and familiarity with the operations of, and upon the performance of my duties as an officer of, Exelon Generation;
